SUBJECT: Quantum Sails – Request for Abatement

SUMMARY OF ITEM TO BE PRESENTED:

As reported at your May meeting, Quantum Sails has provided an application for consideration for personal property tax abatement. Notice has been published in the Record Eagle and notice provided to all taxing jurisdictions. As a reminder this notice to taxing jurisdictions is new with the goal of working with all public taxing jurisdictions to become more aware of abatements and impact.

Request: Quantum Sails has purchased a new machine to make the sail membrane completely at the Traverse City location. The new equipment will allow the sail to be made in the United States, a feature very important to the end user. The cost of the equipment was \$382,000. Equipment was purchased in January, delivered to the business in February or March.

Impact on Taxing Jurisdictions: Quantum Sails received a 4 year tax abatement for personal property and an 8 year real property abatement in 2006 through the East Bay Township Board. This abatement was awarded when Quantum Sails first moved their headquarters to Traverse City, making investment into the current building (real property investment allowing for the 8 year abatement) and making investment in equipment.

The investment made in 2014 is \$382,000 for the new equipment to make the membrane for sails. The job creation is anticipated to be 8 new jobs working first and second shift.

Provided on Attachment A is a breakdown of projected impact on each taxing jurisdiction if this abatement were provided. It is noted that Special Assessments and Debt are not abated. Each year a deprecation value was placed on the equipment to have a more realistic perspective on the impact over a three year period. The abatement value is anticipated to be \$12,207.97 over a 3 year period.

Scoring of Request: I have attached the scoring sheet as created by this Board. Based on the investment and impact, the total score came to 25 total points. Based on the points the Personal Property Abatement is eligible for a 3 year tax abatement.

Required Follow-up: Per policy should abatement be granted, follow-up will occur to ensure that new jobs as identified will be hired and file kept ensuring compliance by the Northern Nexus staff.

RECOMMENDATION: Based on the above outlined information, Quantum Sails meets the threshold of positive impact and is recommended to be granted a 3 year personal property abatement.
