 - Whenever a group wishes to address the NMDC, the Chairperson may require that the group designate a spokesperson; the Chairperson shall control the amount of time the spokesperson shall be allowed to speak, which shall not exceed fifteen (15) minutes.

Economic Development Update

Sych identified the other NMDC's in the State. There are 6 in total, with a seventh pending in the City of Detroit. Korn and Sych attended the Michigan Supply Chain Innovation Summit in Dearborn last August. Sych reported it was well attended and the programs presented were interesting. Also reported: \$175K Revolving Loan Fund (RLF) loan to Kajara's Bridge will create 6 new full time positions; out of the State's 41 RLF's, only 10 are active; State may take back Community Development Block Grants that aren't performing.

Since the local business leader interviews were conducted by Parallel Solutions, an economic strategy concept has been drafted and feedback will be sought from those same business leaders. Derenzy reported a second taxing jurisdiction meeting is anticipated for March. Under consideration is to bring in other entities to help determine vision and next steps.

Economic Strategy

Northern Nexus has been supportive of efforts to develop an economic strategy in Grand Traverse County. Strategy efforts have been taken to identify opportunities to bolster local companies in creating job opportunities and to attract new businesses into the area.

Electro-Optics Opens New Facility

Northern Nexus approved a tax abatement for Electro-Optics Technology (EOT) in 2014. In 2015, EOT opened its new facility in the Peninsula Business Park. The new \$4,000,000 investment in East Bay Township will allow EOT to expand beyond its current 75 positions by adding 25 new jobs. The new 40,000 square foot facility features a nearly 15,000 square ft. clean room. The new space and layout allows for increased efficiency in our workflow and production lines. 80% of EOT's sales are international with a significant portion of their product being shipped out via air.

The other abatement project was Quantum Sails, an international company with its headquarters in East Bay Township. With the help of the tax abatement from Northern Nexus, the company invested \$382,000 into new equipment with 8 new jobs to be created.

Michigan Logistics and Supply Chain

As part of its engagement in with the Michigan Logistics and Supply Chain Steering Team, Northern Nexus representatives attended the inaugural Michigan Supply Chain Innovation Summit on August 30-31, 2015 in Dearborn, Michigan. Hosted by the Michigan Economic Development Corporation and Prima Civitas, the summit covered current best practices in complexity management, talent development and leadership, and supply chain integration.



determines the jurisdiction in which Northern Nexus may apply its tools. The District includes all of the City of Traverse City, the majority of Garfield Township, the northwest corner of East Bay
Township and the Chum's Corner area in Blair
Township.

Northern Nexus is the Next Michigan Development Corporation serving Northern Michigan. Next Michigan Development Corporations (NMDC) were created by PA 275 of 2010 to foster economic opportunities in the State of Michigan. There are currently six (and a seventh under consideration) active NMDCs that can grant incentives not only to new businesses engaged in multi-modal commerce but also to expanding businesses currently residing in Michigan. The designated NMDCs are as follows:



Northern Nexus NMDC: **northernnexus.org**. Located within the Northwest Region of Michigan hosting five participating jurisdictions.

<u>I-69 International Trade Corridor NMDC</u>: **i-69internationaltradecorridor.com**. Located in the East Central Region of Michigan with a depth of 33 participating jurisdictions.

<u>Port Lansing NMDC</u>: **portlansing.com**. Located within the Central Region of Michigan with participation from the City of Lansing and Ingham County.

<u>VantagePort NMDC</u>: **vantageport.org**. Located within Southeast Michigan spanning across nine jurisdictions.

<u>West Michigan Economic Partnership NMDC</u>: **greenlightwm.com**. Located within the West Central Region of Michigan involving participation from seven jurisdictions.

<u>Superior Trade Zone NMDC</u>. Located in the Upper Peninsula of Michigan hosting sixteen jurisdictions.

<u>Detroit NMDC</u>. New legislation allows for a seventh NMDC which is anticipated for the City of Detroit.

Next Michigan Businesses are those located or locating within the NMDC regions that utilize multi-modal transportation in their supply or production chains. NMDCs aim to assist these logistics-based companies and the opportunities offered include renaissance tax-free zones, tax increment financing for infrastructure, and facility and property tax exemptions.
